College Board of Governors approves granting the Right-of-Way and Easement requested by the

Clarksburg Sanitary Board.

BACKGROUND: The City of Clarksburg through the Clarksburg

Sanitary Board is in the beginning phase of upgrading of their sanitary sewer and wastewater infrastructure throughout the City of Clarksburg. To

facilitate these infrastructure upgrades the Clarksburg Sanitary Board is requesting a

temporary and permanent right-of-way through the two parking lots owned by Pierpont across West

Main Street from the Clarksburg Campus.

The two parking lots are located between the Harrison County Chamber of Commerce and the

Clarksburg City Florist.

In addition to restoring the parking lots to their original condition to the reasonable satisfaction of

Pierpont, the two lots will be seal coated and

restriped.

RIGHT-OF-WAY AND EASEMENT AGREEMENT

THIS RIGHT-OF-WAY AND EASEMENT AGREEMENT, made and executed this '____ day of _____, 2024, by and between Pierpont Community and Technical College Board of Governors, on behalf of Pierpont Community and Technical College, a West Virginia agency, hereinafter referred to as the "Grantor", and the Clarksburg Sanitary Board, a municipal corporation, hereinafter sometimes referred to as the "Board," and/or "Grantee",

WITNESSETH: That for and in consideration of the sum of \$1.00 and other good and valuable consideration, the receipt of all of which is hereby acknowledged, Grantor does hereby grant and convey, with covenants of General Warranty, unto Grantee, and to its successors or assigns, temporary and permanent rights-of-way to facilitate surface and underground operations upon a certain tract and parcel of land situate in Clark-Clarksburg Taxing District, Tax Map 18, Parcels 87 and 88.1, Harrison County, West Virginia, and which said tract and parcel of land is further described in a deed recorded in the Office of the Clerk of the County Commission of Harrison County, West Virginia, in Deed Book No. 1716 at Page 273, to which said deed reference is hereby made for all pertinent purposes.

The location of said temporary and permanent rights-of-way and easements proposed upon said property is as follows:

 $\pm 8,065$ square feet of temporary easement and $\pm 1,567$ square feet of permanent easement, as depicted and further described in Exhibit "A," attached and incorporated herein; and,

 $\pm 4,109$ square feet of temporary easement and ± 677 square feet of permanent easement, as depicted and further described in Exhibit "B," attached and incorporated herein.

It is further covenanted and agreed that the Board shall ensure that: (1) Activities upon the parcel authorized by this instrument are conducted with the least possible disruption and inconvenience to Grantor and neighbors; and (2) Any surface disturbance occurring during this use shall be restored to as close as possible to the original condition of the land and to the reasonable satisfaction of Grantor.

This Agreement shall be binding upon the parties hereto, their personal representatives, heirs, successors or assigns.

The undersigned hereby declare:

That the conveyance made in the document to which this declaration is appended is exempt from taxation under the provisions of Chapter 11, Article 22, of the Code of West Virginia, for the reason that it is a conveyance made to a political subdivision of the State of West Virginia.
